Banks Avenue School Enrolment Scheme Amendment

Home Zone Description

The Enrolment Scheme takes addresses on both sides of the boundary roads mentioned in the description, unless otherwise stated.

Starting from the intersection of Shirley Road and Marshland Road, the home zone follows:

- North on the Eastern side only of Marshland Rd to Pagoda St,
- East on Pagoda St to Joy St
- South on Joy St to Golf Links Rd,
- South on Golf Links Rd to New Brighton Rd,
- East on New Brighton Rd to Horseshoe Lake Rd,
- North on Horseshoe Lake Rd to Broomfield Tce (including any addresses on the western side of Horseshoe Lake Road between Broomfield Tce and Lake Terrace Road),
- From the Horseshoe Lake Rd/ Broomfield Tce intersection,
- South on the western side only of Broomfield Tce to Kingsford St,
- East along the south side only of New Brighton Road to Locksley Ave,
- South west along Locksley Ave to Glenarm Tce,
- West along the north side only of Glenarm Tce to the intersection with Gayhurst Rd,
- From this point due West to the intersection of Avonside Dr and Morris St,
- West along the north side only of Morris St to the intersection with Avonside Dr,
- West across the Avon River to the Intersection of Lois Pl and River Rd,
- South, then west along River Rd to Fitzgerald Ave,
- North along the eastern side only of Fitzgerald Ave to Bealey Ave,
- West along the north side only of Bealey Ave to Geraldine St (including the north side of Bealey Ave to Barbadoes St),
- North along Geraldine St to Gresford St (including Purchas St from Geraldine St to Barbadoes St),
- East along Gresford St to Hills Rd,
- North on Hills Rd to Dudley St,
- East along Dudley St to Stapletons Rd,
- North along the east side only of Stapletons Road to Shirley Road,
- East along the south side only of Shirley Road to Marshland Road.

Proof of residence within the home zone will be required.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.

Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home

zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

First Priority	This priority is not applicable at this school because the school does not
	run a special programme approved by the Secretary for Education.
Second Priority	will be given to applicants who are siblings of current students.
Third Priority	will be given to applicants who are siblings of former students.
Fourth Priority	will be given to any applicant who is a child of a former student of the
	school.
Fifth Priority	will be given to any applicant who is either a child of an employee of the
	board of the school or a child of a member of the board of the
	school.
Sixth Priority	will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, Selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary. Under Section 11G (1) on the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.

Appropriate maps are available at the school and may be viewed to give guidance in identifying the schools' geographical zone.

The Board will assist the Principal to monitor roll trends and enrolments to ensure that the application of the scheme is consistent and fair to all.

The Board expects that parents / caregivers will act within the spirit intended by this policy.

The Board reserves the right to review, amend, suspend or abandon this policy subject to the Education Amendment Act (No2) 1998 Sections 11J and 11K

The decisions made by the Board and Principal with respect to applications for enrolment and using the criteria outlined above will be final.
